



Article 1 - Objective

The Mauritius Real Estate Awards, hosted by PropertyCloud Limited, is an annual event designed to recognize and reward outstanding achievement for industry stakeholders. The objective is to award and distinguish individuals, entities, companies, solutions, stakeholders and projects that stand out for their competence, quality, innovation and positive contribution to the Mauritian real estate sector.

Article 2 - Categories & Criteria

The awards shall consist of 3 main categories with associated criteria listed below.

Article 3 - Submissions

Final date for submissions is 10 November 2023. Candidates are solely responsible for organizing their submission for the Mauritius Real Estate Awards, namely through the provision of required information via completed form and supporting documents through the official website channel of propertycloud.mu/awards. All candidates must provide a copy of their official Business Registration Number (BRN). Material and supporting documents must be in PDF format, contain a description of the project, sizing, location, illustrative graphics (images), associated amenities / unique characteristics, technical data of the team/architects/engineers, and be accompanied by the required legal certificate/s attesting the project approval.

* Categories involving projects must have already commenced construction and/or have been completed - projects that are yet to start construction will be not considered. Categories involving Estate Agents do not need to enter as these awards will be preselected based on internal data collected by PropertyCloud Limited.

Article 4 - Judging and finalists

The appraisal of submissions by nominees for Residential and Commercial categories will be made by an independent Judging panel composed of experts, technically and professionally representative of the sector, invited by PropertyCloud. The Panel will be overseen by external auditors to ensure an impartial process. The complete composition of this Panel will be made public at the awards ceremony. The evaluation criteria on which the Panel will base its decision is listed as per above Article 2 and Article 3. The panel review will be held in private and determined by weighting scale rankings of the allocated criteria. Panel members who have had or have direct, personal or business connections with any of the projects under consideration, shall declare the fact or its eventuality to the other members and may not vote on it. Any situations in which this Regulation proves to be insufficient will be resolved by the Management of PropertyCloud, as well as the legislation in force. The results will be kept confidential until the award ceremony with the Top 3 finalists notified by 23 November 2023.

Article 5 - Awards ceremony and gala evening

An exclusive gala-evening ceremony will be held to announce the winners on 30th November at the Intercontinental Hotel in Balaclava. At the ceremony, allusive trophies and certificates will be delivered to a representative of each award-winning enterprise or entity. Up to 120 selected guests, finalists, and media will be invited to attend the awards ceremony event.
